A RESOLUTION OF THE SPRECKELS COMMUNITY SERVICES DISTRICT DISTRICT BOARD DIRECTING PREPARATION OF THE ENGINEER'S REPORT FOR THE CONTINUATION OF THE LANDSCAPING, LIGHTING, AND STORM DRAINAGE DISTRICT FOR FY 2024-25

WHEREAS, the District Board of the Spreckels Community Services District proposes to continue the annual assessments during 7/1/24-6/30/25 for the Landscaping, Lighting, and Storm Drainage District which was previously formed in accordance with the Landscaping and Lighting Act of 1972 (Streets and Highways Code Section 22500, et seq.); and

WHEREAS, the Streets and Highways Code Section 22622 requires the governing body of a local agency to adopt a resolution ordering the preparation of an engineer's report and to generally describe any proposed new improvements and/or substantial changes to an existing improvement prior to levying and collecting an annual assessment for an existing Landscaping and Lighting Assessment District.

NOW, THEREFORE, BE IT RESOLVED BY THE DISTRICT BOARD OF THE SPRECKELS COMMUNITY SERVICES DISTRICT AS FOLLOWS:

<u>Section 1:</u> The annual Engineer's Report for Landscaping, Lighting, and Storm Drainage District shall be prepared by SCI Consulting Group who is designated the Engineer of Work; thereafter the Report shall be filed with the Clerk for submission to the District Board:

<u>Section 2:</u> Any new improvements and/or substantial changes in existing improvements that are proposed to be paid for out of the 2024-25 annual assessments will be specified in the Engineer's Reports.

<u>Section 3:</u> This resolution is adopted pursuant to Section 22622 of the Streets and Highways Code.
