## SPRECKELS COMMUNITY SERVICES DISTRICT RESOLUTION <u>2024-02</u>: A RESOLUTION TO RESTRICT FUNDS RECEIVED FROM THE SPRECKELS TOWN IMPROVEMENT COMMITTEE TO TRAFFIC SAFETY IMPROVEMENTS ONLY.

WHEREAS, a settlement agreement was executed November 16, 2005, ("Settlement Agreement") which resolved multiple lawsuits concerning the Town of Spreckels, specifically Monterey County Superior Court Case Nos. M69751, M71292, and M76547;

WHEREAS, in addition to other matters addressed therein, the Settlement Agreement required the creation and funding of the Town Improvement Fund, overseen by a The Town Improvement Fund Committee ("The Committee") empowered with expending the funds for projects for the betterment of the Town of Spreckels;

WHEREAS, The Committee has authorized distributing funds to the Spreckels Community Services District to be used for traffic safety improvements benefitting the Town of Spreckels; and

WHEREAS, The Committee has requested that Spreckels Community Services District, as a condition of receiving said funds, commit by official action to setting aside the funds and only expending them for their stated purpose.

NOW, THEREFORE, BE IT RESOLVED, the Board of Directors of the Spreckels Community Services District hereby resolve that the funds it receives from The Committee shall be earmarked and spent only for its intended purpose, specifically, that the funds be used for traffic safety improvements benefitting the Town of Spreckels.
