

# 2016 MUNICIPAL SERVICE REVIEW AND SPHERE OF INFLUENCE STUDY

# Spreckels Community Services District Spreckels Memorial District



Adopted by the Commission March 28, 2016



The Memorial District was formed in 1947 under the California Military and Veterans Code. The primary purpose of a memorial district is to provide buildings and facilities for the use of "veteran soldiers, sailors, and marines who have honorably served the United States." The act also allows the District to make these services available to the general public.

Both districts are local government bodies within and surrounding Spreckels, an unincorporated community located south of Salinas and near the Salinas River. Since the populations of the two districts are small, there are limited numbers of local voters who are interested in serving on the Boards. Three individuals currently serve on both of the five-member Boards. The two districts share an office, meeting space and a part-time Business Manager / Board Clerk.

Board members of both districts are interested in exploring ways in which they can work closer together to be more efficient and effective, including the possibility of some form of consolidation if this would improve service and simplify operations. Board members have requested LAFCO's assistance in identifying potential future consolidation options. Because of the different missions of these Boards, it is unclear if existing State law would permit a full legal consolidation action. Other options may include increased integration of district functions and boards while still maintaining two legally separate districts. Key goals of any consolidation measures would be cost savings and improvements in service delivery. LAFCO staff looks forward to working with district representatives in exploring future options.

2. The two districts' existing boundaries and Spheres of Influence are appropriate and not in need of adjustments at present.

The two districts' Spheres of Influence and boundaries are adequate to meet current needs. The District has not requested any changes. LAFCO staff concurs that no changes are currently warranted. As discussed above, the two districts are interested in exploring the feasibility of a full or partial consolidation. A consolidation proposal, if approved by LAFCO, might involve changes to existing boundaries and Spheres of Influence.

3. The Community Services District is encouraged to explore the potential benefits of becoming active in water- and sewer-related services, and to explore the long term opportunity to connect the community's wastewater and storm water systems to the regional wastewater treatment facility. Spreckels is a wastewater opportunity area for the regional facility.

In 1989, Spreckels voters authorized the Community Services District to provide water and sanitary sewer services within District boundaries. To date, the District has not exercised these powers. The services are currently provided by private entities. LAFCO encourages the District to explore the long term feasibility and potential for public benefits that may result from water and/or sanitary sewer services being provided and administered under public ownership.

Also, the District is encouraged to explore the potential to eventually connect the Spreckels sanitary sewer system (currently privately owned by Cal Am) to the regional wastewater treatment facility in Marina, via a connection point south of Salinas. Such a connection would allow for a greater level of groundwater protection and an increase in reclaimed water for the region. It may also be feasible to eventually connect the District's storm water drainage system, which does not allow storm water to be treated before it is released into the Salinas River, to the regional system. As a first step in contemplating these potential scenarios, the District may wish to request a presentation about the regional facility's activities and opportunities for partnerships.

Dear Kate,

The atmospheric river event of January 2023 caused two failures at our 2<sup>nd</sup> Street pump station. First, because of an increase in back pressure due to the level of the Salinas River being above the end of the 24" outflow pipe that runs across Spreckels Boulevard and the Tanimura and Antle property, a leak opened at the pipe next to the pump station. This was repaired by Don Chapin company on an emergency basis. Second, one of our 75 hp pumps was damaged and had to be replaced. The total cost of both these projects was just under \$100,000. They were submitted as FEMA disaster claims. Both claims have been approved and we are waiting for the funding to arrive from Cal OES.

The back pressure event last year must have caused further damage to the outflow pipe because during the first major atmospheric river event of this season, about 900 lineal feet of the outflow pipe failed on the Tanimura and Antle property. This is a major failure and the one estimate we have received comes in at \$225,000. Fortunately, the storm water is flowing into an old settling pond and causes no risk of flooding that will affect ag operations for T&A. Though this can be considered an emergency where we can approve the repairs on an expedited basis, we are nearing the end of the rainy season and the project can wait, if other options are to be considered. FEMA has recommended we work with Cal OES to try to tie this to the existing disaster damage of last year. If that funding is possible, we can go forward with the repair, though we will have to tighten our belt until all FEMA funding has arrived. Supervisor Lopez has also indicated that we may be able to piggyback onto the County's continued efforts to address outstanding issues related to last year's disaster. There is also the reality that the rest of the outflow pipe, between the pump station and Spreckels Boulevard, runs between the new two story Standard Pacific homes and the old one story homes. The pipe used was installed in 1960 and had a 25 year life then. It is a very fragile fiberglass product that could fail again in the future.

Attached is page 8 from LAFCO's 2016 Municipal Services Revue, where you recommend SCSD consider tying our sewer and storm water into the regional wastewater project. If this were put into action, it would make the outflow pipe to the Salinas River no longer necessary. So it should be considered that possibly repairing the current damage is not a good use of District funds and the outflow pipe damage should be covered up and abandoned. The community is also becoming aware that there may be major issues with the existing sewer mains owned by Cal Am. We had a failure of the sewer lateral at the Park restroom that crosses Llano Avenue. Video showed that the pipe to be in very bad shape. Repaving of Spreckels streets is on the County's radar but everyone wants to make sure that tearing up the streets to replace the sewer and storm water pipes has been considered before the paving is done.

I know it is a huge undertaking to consider tying into Monterey One, which should include replacing the sewer mains and abandoning the Cal Am sewer treatment facility, then also running a main for waste and stormwater up Harkins road to tie into the main at Abbott Street. The cost of the outflow pipe repair pales in comparison to the ultimate cost of a new system, so it may be that repairing the pipe is the best and only option at this time. I just think this is an opportunity to look into the future a little. It's kind of beyond my capability to advise my board, so this would be more of a regional conversation with other stakeholders above SCSD to assess and develop a plan. President Mike McTighe and board member Otto Kramm work closely with Supervisor Lopez on various issues, and T&A CAO Kerry Varney, a Spreckels resident, may be joining our board. So the district will be entering a good period for having these conversations.
